TERMS OF REFERENCE- REQUEST TO APPOINT A SERVICE PROVIDER TO PROVIDE A LEGAL ONLINE LIBRARY PLATFORM

1. BACKGROUND

- 1.1. The Gauteng Partnership Fund (“GPF”) is a schedule 3C Provincial Public Entity that was founded in 2002 as a Benevolent Trust under the Trust Properties Control Act 57 (1988), by the Executive Authority of the GPF, Gauteng Department of Human Settlements (“GDHS”). The mandate of the GPF is to serve as GDHS’s capital raising and implementing agent regarding identified Mega Projects in the Gauteng Province.
- 1.2. In order to assist the GPF in executing its mandate, the Legal, Compliance and Risk business is required to do but not limited to the following:
 - 1.2.1. draft and review agreements and other legal documents,
 - 1.2.2. provide well researched legal opinions to the various business units within GPF,
 - 1.2.3. manage litigation by and against the GPF,
 - 1.2.4. act as an independent review body to ensure that compliance issues/concerns within the organization are appropriately evaluated, investigated and resolved.
- 1.3. The GPF is consistently trying to find new and innovative ways to improve their systems and processes so that the organizations performance remains consistently high.
- 1.4. The duties and responsibilities of the officials within the Legal, Compliance and Risk business unit are in line with the requirements stated in clause 2.2 above.
- 1.5. Most times, Google is utilized to conduct legal research. This has high risk implications and it is not always easy to verify the correctness and reliability of information which is sourced from a search engine such as Google.

2. BUSINESS REQUIREMENT

- 2.1. Accordingly, a comprehensive online legal library is required to assist the officials within the business unit to execute their duties and responsibilities.
- 2.2. Particularly, the officials within the Legal, Compliance and Risk business unit –
 - 2.2.1. require a comprehensive online legal platform for conducting legal research;
 - 2.2.2. access to a legal commentary on all areas of the law;
 - 2.2.3. a complete collection of Acts, Bills, By-laws, Gazettes;
 - 2.2.4. case law; and
 - 2.2.5. access to the latest form and precedents in the various areas of the law.
- 2.3. This will enable the officials to have access to a comprehensive library which covers various areas of the law e.g. corporate and commercial law, civil procedure, construction law, property law and not just labour law (as per the current subscription with GPF).
- 2.4. This will be cost saving exercise as most work can be done internally thereby saving on the external legal spend. This will also allow for improved turnaround times in providing the required support from the unit.
- 2.5. Access to the system can be provided to officials outside Legal, Compliance and Risk i.e. Secretariat, IT and Human Resources who may require the use of online legal research tools.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
